#### **WEEK IN REVIEW**

- · ANIMAL WELFARE HAD 33 ANIMALS ADOPTED AND 10 ANIMALS RECLAIMED BY THEIR OWNERS. ADDITIONALY, THEY TOOK A TOTAL OF 71 ANIMALS INTO THE ANIMAL WELFARE CENTER. ANIMAL WELFARE CURRENTLY HAS 284 ANIMAL IN THEIR CARE WITH 69 OF THOSE ANIMAL BEING PLACED IN FOSTER HOMES.
- PATROL RESPONDED TO A REPORT OF AN INJURY COLLISION NEAR THE INTERSTATE 35 OFF-RAMP TO HIGHWAY 9 INVOLVING ONE VEHICLE ON JULY 2 AT 12:24AM. THE INITIAL INVESTIGATION INDICATED THAT THE VEHICLE LEFT THE ROADWAY DUE TO AN UNKNOWN REASON AND CRASHED INTO A CONCRETE PILLAR. THE COLLISION IGNITED A VEHICLE FIRE. THE ONLY OCCUPANT OF THE VEHICLE WAS PRONOUNCED DECEASED AT THE SCENEDUE TO INJURIES SUSTAINED DURING THE INITIAL COLLISION. THE COLLISION IS UNDER INVESTIGATION BY THE NPD/OUPD CIRT TEAM.
- PATROL RESPONDED TO A REPORT OF AN ALARM AT A BUSINESS LOCATED IN THE 1700 BLOCK OF 24TH AVE SW ON JULY 8 AT 12:41AM, UPON ARRIVAL, OFFICERS WITNESSED THREE SUBJECTS RUNNING FROM THE AREA. A PERIMETER WAS ESTABLISHED AND ALL WERE TAKEN INTO CUSTODY WITHOUT INCIDENT. THE THREE SUBJECTS WERE LATER DETERMINED TO BE RUNAWAY JUVENILES FROM AN AREA GROUP HOME. ALL WERE TRANSPORTED TO A JUVENILE FACILITY ON COMPLAINTS RELATED TO BURGLARY AND POSSESSION OF STOLEN PROPERTY.
- PATROL RESPONDED TO A REPORTED ROBBERY INSIDE A BUSINESS IN THE 3300 BLOCK OF W. MAIN ST ON JULY 7 AT 11:47AM. THE INITIAL INVESTIGATION INDICATED THAT THE SUSPECT REQUESTED TO LOOK AT VARIOUS ITEMS IN A LOCKED CASE. AFTER THE EMPLOYEE OPENED THE CASE. THE SUSPECT PUSHED THE EMPLOYEE TO THE GROUND BEFORE LEAVING THE AREA WITH THE CONTENTS OF THE CASE. THE SUSPECT HAD LEFT THE AREA BEFORE OFFICERS ARRIVED. THE INCIDENT REMAINS UNDER INVESTIGATION BY THE CRIMINAL INVESTIGATIONS DIVISION.
