

WEEK IN REVIEW

- OFFICERS RESPONDED TO THE CAMPUS CORNER AREA ON 10/29 FOR A REPORT OF A FIGHT. ONCE ON SCENE, OFFICERS LOCATED TWO VICTIMS -- ONE WHO HAD BEEN KNOCKED UNCONSCIOUS AND ANOTHER WHO HAD BEEN STABBED MULTIPLE TIMES DURING THE INCIDENT, BOTH VICTIMS WERE TRANSPORTED TO AREA HOSPITALS FOR TREATMENT OF NON-LIFE-THREATENING INJURIES. THE INCIDENT REMAINS UNDER INVESTIGATION.
- · COMMUNICATIONS RECEIVED A CALL OF A VEHICLE DRIVING ON THE WRONG SIDE OF FLOOD AVE. NEAR ROBINSON ST. AT 10:50AM ON 10/29. AN OFFICER IN THE AREA SAW A VEHICLE MATCHING THE DESCRIPTION DRIVING ERRATICALLY AND ATTEMPTED TO INITIATE A TRAFFIC STOP. THE DRIVER DID NOT STOP AND CONTINUED TO WEAVE ACROSS THE ROADWAY. AN OFFICER SUCCESSFULLY CONDUCTED AN INTERVENTION TACTIC STOPPING THE VEHICLE. THE DRIVER WAS SUBSEQUENTLY ARRESTED FOR DUI AND OTHER OFFENSES.
- · AFTER A 15-MONTH HOMICIDE INVESTIGATION, A JURY CONVICTED DESIREE SANCHEZ OF FIRST DEGREE MURDER AND IMPROPER REMOVAL OF A BODY. THIS CASE BEGAN WHEN OFFICERS LOCATED THE BODY OF MAGGIE SANDOVAL IN BOX AT A NORMAN RESIDENCE IN 2021 FOLLOWING RECEIPT OF A TIP. SANCHEZ WAS SENTENCED TO LIFE IN PRISON.
- · OFFICERS RESPONDED TO A REQUEST FOR A WELFARE CHECK ON A DRIVER ASLEEP IN THEIR VEHICLE IN THE 2400 BLK OF NW 36TH ON 11/3. OFFICERS FOUND THE SUBJECT SLUMPED OVER IN THEIR VEHICLE AND SUBSEQUENTLY ARRESTED THEM FOR DUI. OFFICERS ALSO FOUND TRAFFICKING AMOUNTS OF FENTANYL PILLS, OTHER DRUG PARAPHERNALIA, AND A LOADED HANDGUN IN THE VEHICLE.
- OFFICERS RESPONDED TO A REPORT OF AN INJURY COLLISION INVOLVING A VEHICLE AND MOTORCYCLE NEAR 12TH AVE SE AND LINDSEY ST. ON 11/3. THE MOTORCYCLE DRIVER SUFFERED SIGNIFICANT INJURIES DURING THE COLLISION AND WAS TRANSPORTED TO AN AREA HOSPITAL IN CRITICAL CONDITION. THE COLLISION REMAINS UNDER INVESTIGATION BY THE NPD/OUPD CIRT TEAM.
